## O34/22 Apologies, Declarations of Interest and requests for dispensation

Apologies were noted from Cllrs. R. Banks, T. Bounds, R. MacCurrach, I. Spencer and R. Warne. There were no declarations of interest and no requests for dispensation.

#### 035/22 **Minutes**

The Minutes of the meeting held on 6<sup>th</sup> June, which had been previously circulated, were accepted and the Chair was authorised to sign the Minutes as a true record of proceedings at that meeting.

#### 036/22 Clerk's Report

The Clerk's report, as attached to these Minutes, was noted.

#### 037/2022 Community Asset Transfer of Crooked Well

- (a) It was noted that the decision to accept the transfer of Crooked Well meadow from Herefordshire Council had been confirmed some three years ago, the delay by Herefordshire Council is concluding this transfer now requires confirmation of the agreement to proceed. After some discussion, it was resolved to proceed with the transfer of Crooked Well Meadow to Kington Recreation Ground Trust, subject to contract.
- (b) It was resolved to formally request that Kington Town Council appoint legal advisors to undertake the transfer of Crooked Well meadow as agreed above, the costs of which will be borne by the grant awarded by Kington Town Council to the Trust. Members expressed a preference for a local firm to be appointed, if possible. It was further agreed that solicitors be requested to ascertain from Herefordshire Council when the last tree safety survey has been conducted on the land to be transferred and for a copy of the latest play equipment safety survey in addition to the usual enquires before contract.

#### 038/22 Toilet block handwash units

Noting that the contractor currently servicing the handwash units in the toilet block is no longer able to guarantee that the units can be repaired as the units are now considered obsolete, it was agreed not to replace those units at this stage pending refurbishment of the toilet block which it is hoped will take place shortly.

#### 039/22 Refurbishment of benches

Members noted that several of the original metal benches in the Recreation Ground would benefit from a refurbishment and the Mayor reported that initial investigation into the possible cost of doing so suggested a budget price in the region of £8,000 - £9,000 in total for the refurbishment of all 13 benches. After some discussion, it was agreed that:

(a) The management group would be requested to agree a specification for the refurbishment work so that alternative quotes can be obtained in accordance with financial regulations;

(b) That consideration be given to possibly enabling the sponsorship of benches as memorial benches at a later date, noting that this will require a review of the recently agreed memorial bench policy.

#### 040/22 Playground Inspection Report

Receipt of the playground inspection report for 2022 was noted. It was agreed that this be referred to the Management Group to review and recommend action to deal with any issues raised therein.

#### 041/22 **Next Meeting**

The next meeting will take place on Monday 7<sup>th</sup> November 2022. The following items were agreed for the next meeting:

- Report on progress of the Community Asset Transfer
- Report from the Management Group on actions required following the play equipment survey

Agenda item 3: Clerk's Report

This report covers items for information which are not addressed elsewhere on the agenda:

#### 1. Traveller Encampment

Members will be aware that on 2<sup>nd</sup> August 9 traveller caravans/mobile homes entered the recreation ground by cutting through a padlock on one of the gates. This was the first such incident on the recreation ground and obtaining advice and guidance on how to deal with this proved difficult. However, on Friday 5<sup>th</sup> August, the Clerk and Mayor, accompanied by PCSO Felix Rawlinson served a notice on the travellers to leave the site within 48 hours and by Sunday 7<sup>th</sup> August they had left. Although there was some minor damage to the surfaces of the recreation ground as a result of the driving of quad bikes etc. around the site and a large quantity of rubbish left, albeit in bags, damage was relatively light.

A formal review of security of the site will need to take place.

#### 2. Recreation Ground Shed

The storage shed in the Recreation Ground has been cleared by a group of councillors working with ground staff with all redundant Christmas lights and other items disposed of via a skip. Thanks to all involved in this.

#### 3. Staff Review

There has been no progress on this item since the last meeting due to other commitments.

#### 4. Memorial Bench

The installation of the memorial bench for the late Dick East was delayed due to the traveller encampment at the request of the family. Holidays have delayed the date for the installation being re-set but it is anticipated that work will take place in September or October.

Work on the Covid Memorial bench should now have started with an anticipated delivery date in October.

#### 5. Recreation Ground Cottage

Also delayed due to other commitments and holidays, the replacement guttering for Rec Cottage is due to be completed later this month.

#### 6. Kington Vintage

Kington Vintage returned to the Recreation Ground this year after an absence due to covid and went well. Ground staff have reported some minor damage to the toilets during that weekend with toilet seats now requiring replacement.

#### 1. Staff Review

There has been no progress on this item since the last meeting due to other commitments. This will be an agenda item for a meeting of the personnel committee.

#### 2. Memorial Bench

The installation of the memorial bench for the late Dick East was delayed due to a number of reasons but has now been completed by our groundsman.

The Covid memorial bench is also due for installation in the immediate future. Installation is to be overseen by the artist. There remains the matter of the commorative stone to be place alongside the bench. The wording and quotations for engraving are to be obtained.

#### 3. Recreation Ground Bench Refurbishment

This project has not progressed due to other commitments. Comparative quotes will need to be obtained in accordance with financial regulations.

#### 4. Anti Social Behaviour

Tins of baked beans were recently poured over the skate park by persons unknown. Cleaning up afterwards proved to be a particularly difficult as ground staff have no access to a pressure washer. An urgent review of equipment is needed if ground staff are to function efficiently.

#### 5. Cricket Club Lease

There has been no further progress on this item

#### 6. Tree Survey

There has been no progress on the redrafting of the specification for the tree survey due to other commitments.
