A query relating to river safety was raised and noted that Environment Agency and/or National Rivers Authority cover matters relating to river safety.

## 2) Town Centre

The Mayor noted that the Economic Development Plan by Herefordshire Council will be considered at Herefordshire's September Cabinet Meeting and contains proposals for support for the town centre.

Members noted appreciation for the litter pick undertaken by the Chamber of Trade, supported by KLEEN and others, in preparation for the re-opening of the High Street. The efforts of all volunteers who support the town should be noted and celebrated.

It was agreed to look into responsibility for pavement sweeps in particular at a later meeting.

# 3) Kington in Bloom

Members noted with thanks the efforts of the Kington on Bloom working group and commented on the success of the planting this year. A report from Cllr. Dennis was noted. The Clerk reminded members of the need to comply with financial regulations when undertaking any project.

## 4) Allotments

There was nothing to report on this agenda item.

# 5) Recycling

It was reported that the recycling centre continues to work well with prior booking still a requirement. The results of the recycling survey undertaken by Herefordshire Council have not yet been published but are due to be put to Herefordshire Council for consideration.

# 6) Churchyard

The Green Spaces Administrator reported that the Community Payback Team have now started work in the Churchyard undertaking some clearance work and cutting back of overgrown vegetation and removal of ivy from memorials and walls. At the request of the Church the compost bins are to be removed as they have become litter bins rather than compost bins. It was agreed to ask the allotments society if they wished to take the material from the bins for composting on the allotments.

Quotations are currently being sought to remove two dead trees from the churchyard.

#### 7) **Community Energy**

There was nothing to report on this agenda item.

# 8) Economic Development

As noted previously Herefordshire Council's Economic Development Plans for the Market Towns are progressing and are to be considered by Herefordshire Council in September.

#### 9) War Memorial

The working group set up to consider this further has not yet met but members noted that the area has been tidied by a member of the public.

#### 10) Trees

It was noted that broken branches by the footpath adjacent to the Co-op car park have now been removed. Trees in the Mill Street Car Park are to be reported to Balfour Beatty/Herefordshire Council as the metal cages are cutting into the tree and should be removed.

## 11) KLEEN

It was reported that KLEEN are working with landowners with a view to establishing a community garden at Lower Cross with support from funding through the Prime Foundation.

The Car Share Club has not yet restarted.

Nothing further has been heard from Cllr. Harrington with regard to the request for additional bus services.
