001/24 Apologies, Declarations of Interest and Requests for Dispensation.

Apologies were noted from Cllrs. T. Bounds and N. Cornish. There were no declarations of interest and no requests for dispensation.

002/24 Minutes

The minutes of the meeting held on 6th November 2023, which had been previously circulated, were accepted and the Chair was authorised to sign the minutes as a true record of proceedings at that meeting.

003/24 Exclusion of the Public

It was agreed that due to the confidential nature of the business of the next two agenda items, that members of the public be excluded from the following two agenda items in accordance with the provisions of the Public Bodies (Admission to Meetings) Act 1960 (3).

004/24 Cricket Club lease

Cllr. R. Banks outlined discussions with Kington Cricket Club explaining the Trust's proposal to ask lawyers to draft a new lease to include new provisions for rental payments. Noting that this may take some time as it may require the proposals to be sanctioned by the Charity Commission, the Cricket Club has requested a letter of intent which it can then use to help with applications for funding. After due consideration, it was agreed that a letter be sent in accordance with the draft as circulated.

005/24 Land Registration

Solicitors acting on behalf of the Recreation Ground Trust in the matter of registration of the land forming the Recreation Ground have advised that some original documentation confirming the Town Council as Trustee of the Recreation Ground Trust will be required by the Land Registry. The whereabouts of the original documentation which would date from around the time the Town Council was formed, is unclear. Solicitors will clarify where this documentation might be held with Herefordshire Council but in the absence of the original, have suggested that a Statutory Declaration may be acceptable to the Land Registry.

006/24 Acquisition of Crooked Well meadow

The clerk reported that the solicitors have not yet commenced work on the requested searches. An invoice has been requested for the additional fees requested by the solicitors but not yet received.

007/24 Recreation Ground Tarmac Path

Potholes in the public right of way path across the Recreation Ground have been reported to BBLP and accepted by them for repair. The Assistant Clerk will clarify if or when these are to be repaired. In the meantime, it was suggested that grant funding from the Lottery or the Landfill

Communities fund might be available to fund repairs. This will be reviewed at the next meeting.

008/24 Toilet Block Refurbishment

It was agreed that the Management Committee be tasked with drawing up a specification for the refurbishment of the toilet block with a view to presenting their recommendations to a meeting of the Trust within the next few months.

009/24 Clerk's Report

The Clerk's report, as attached to these Minutes, was noted.

010/24 Financial Matters

a) Financial Report for period to 31.12.2023

This report was not yet available and will be presented to the next meeting of the Trust.

b) 2024/5 Operating Budget

The budget as attached to these Minutes was agreed.

c) Grant request to Kington Town Council for year 2024/5

As noted in the 2024/5 budget, it was agreed that a request for £97,000 from Kington Town Council for goods and services to maintain the Recreation Ground and Crooked Well, once acquired.
