Activities since the last report on 20<sup>th</sup> April

Wed 22<sup>nd</sup>: I met with representatives of St Mary's Church, OAK and CLC to carry out a mapping exercise looking at various community activities being offered by these organisations. This helped us to see where the gaps and overlaps are and to plan for the future.

Frid 24<sup>th</sup>: I attended the presentation ceremony at the Burton Hotel when the King's Award for Voluntary Service was presented by the Lord Lieutenant. This was a very happy occasion, a great honour for the Kington Walks Committee and volunteers, but also a great accolade for the town.

Sunday 26<sup>th</sup> I attended a service of thanksgiving for the year of the Mayor of Hereford. It was good to see the huge variety of activities which involved the city Mayor, the links between the city into other countries and communities.

Friday 1<sup>st</sup> May I was invited to make a speech at the opening ceremony of the Marches Makers Festival. This was a great show case for the talent, skills and creativity of so many local artists and makers. Wonderful works of art and artefacts were on display in the church and at many other venues around the town. It is one those special events that makes Kington the place it is, and sets us well in the arts and culture of the county.

Sat 2<sup>nd</sup>: I attended a superb concert in St Mary's as part of the Marches Makers Festival. KTC had help to sponsor this concert through a community grant. It was a very accomplished concert given n by local musicians. Again , something of which we can all be proud.

Thurs 7<sup>th</sup> May Cllr. Banks and I met to draw up a list of people to be invited to the forthcoming Armed Forces Day celebrations. Invitations are due to be sent out in the next week or so.

Other news:

I was delighted to collect a good number of colourful and imaginative posters from the Primary School, following the launch of the anti- litter/dog mess project. Copies are to be distributed to shops, library, doctors' surgery and other venues around the town.

I was also pleasing to note that the school, have set up an Environment Club. This has involved members of the club picking up litter around the town, especially at the Recreation Ground. The Clerk has written to thank the children for their posters and help.

Armed Forces Day (27<sup>th</sup> June) approaches fast. A great deal of planning, thinking, talking and activity has gone into ensuring the success of this event.
