Catchment Sensitive Farming - Water Grant and Mid-Tier Scheme

The Water Grant and Mid-Tier schemes are both part of Countryside Stewardship and are now open for this year. There are a large range of options and capital items through the scheme that can benefit both your business and the environment, many of which offer fairly generous payments. Some options such as concreting, roofing and tracks are only available to priority holdings within the Wye and Teme catchments with approval from a Catchment Sensitive Farming Officer (CSFO), but many of the options are available to all applicants.

A number of the capital items require a certain amount of evidence (such as planning permission etc.) to be submitted with the application. This can take a while to sort out, so if you're interested its best to get started as soon as possible.

The last date to request an application form is **30th July 2017**, and the deadline for applications is **30th September 2017**, with successful agreements due to start on 1st January 2018. If you are applying for items requiring CSFO approval you need to contact your CSFO by **15th August** to book up an appointment.

Catchment Sensitive Farming Advice Visits

Teme

CSF offers a number of free farm advice visits to Priority Holdings in the Wye and Teme catchments. The visits are completely confidential and designed to help farmers with various issues around soil and water health on their farms. Some of the most popular visits last year were:

Farm Infrastructure Audits - A detailed look into your farmyard, buildings, silage/slurry stores etc with practical advice on current regulations and potential improvements that could be made.

Biobed and Sprayer washdown area Design Visit – Gives practical advice for farmers considering installing a sprayer washdown area with biobed or bio filter, including siting and size considerations as well as management and current regulations.

Nutrient Management Plan – Intended for farmers not currently testing soil nutrient levels. The adviser will sample up to five fields, and then give recommendations based on the findings.

Soil Husbandry Visit – Practical soil management advice including digging a number of soil pits and discussing positive soil management for increased productivity and soil and water health.

Tours of Moseley Common SSSI depart at 4.00pm and 5.30 pm.

Moseley Common (now enclosed) is an SSSI on the Norman family farm. It is a 12 acre area of wet meadow and bog that has been known to naturalists since the nineteenth century. Although under-drained during WW2 it has never really been reclaimed for farming. During the last 3 years more than 250 species of plant have been identified, many rare in Herefordshire. A license has been obtained from Natural England to mow part of it (and collect seeds) to spread (strew) on an adjacent small field to attempt to expand the area. Come and see the SSSI, collect some seed and help to spread in the 'new field'. Also hear about a parallel Facilitation Fund project running on the Curl Brook that runs through the SSSI.

A 'Nuffield' provides funding, opens doors and creates global opportunities to meet people from across the whole sphere of agriculture, leading farmers, farming entrepreneurs and innovators, agricultural leaders and decision makers, people at all levels of research and development and people in the allied and food industries. Many countries have a similar scheme and their scholars are very willing to assist visiting scholars from the UK.

More than twenty Herefordshire people have had a Nuffield Farming Scholarship, so it is very likely you probably already know one or more of them, it's a unique opportunity not to be missed, so why not apply to join them.

News from the Blues – West Mercia Police

Message from Paul Crumpton - The shocking terrorist events in Manchester & London over the last few weeks reinforce to me how crucial any concerns or suspicions that we may have about anyone or anything, no matter how trivial they may seem, should be reported to 101 for non-emergency or 999 for emergency calls.

So in a similar vein, and in relation to <u>a number of Rural Thefts</u> across the County I'm going to ask for just one thing this month. We would be very interested to locate the following vehicle and its occupants. If it's seen acting suspiciously report sightings to 101 or if a crime in progress dial 99 - **GREY FORD TRANSIT VAN VRM: NJ61JGV**

Please beware of this telephone scam

WM Police are receiving a number of calls from concerned residents reporting multiple calls from persons purporting to be from the HMRC. The general theme is that answerphone messages are left asking the resident to phone a number back immediately or be threatened with legal action. If the number is phoned, someone tells the resident that they have defaulted on their tax and asks them to pay a (large) sum of money, threatening the resident that they will have their possessions removed and face arrest. The conversations are a more in depth than the above wording and can be very convincing, enough to cause alarm and concern.

Please be advised this is another scam along the HMRC theme. The perpetrators continually tweak the theme, enough to scare and frighten some people. If you receive such phone calls delete the message, do not phone the number given; if you answer such a call hang up, do not divulge personal information. Please be vigilant to this, keep an eye on anyone who may perhaps be convinced by this as the callers persist by leaving multiple messages.

The Prince's Countryside Fund

What will the LEADER Programme do?

The main objective is to create jobs and economic growth by supporting rural businesses. The programme themes are:

- Support for micro and small enterprises, including farm diversification
- Support for rural tourism
- Support for increasing farm productivity
- Support for increasing forestry provision
- Provision of rural services
- Support for cultural and heritage activities

Who can apply?

Project applications will be eligible from:

- Micro businesses (0-9 employees) and small businesses (10-49 employees)
 - Qualifying micro and small farming and forestry businesses
- Social enterprises
- Voluntary organisations
- Community groups
- Parish councils based in rural Herefordshire

How will I know if our project is eligible?

LEADER funding contributes to around 40% of total project costs. Cash match funding will be needed for around 60% of each project. This is a predominantly capital grant programme. Training, skills and running costs are not eligible for funding. Business addresses must be registered in the Herefordshire LEADER area.

What outputs could my project achieve?

An output is a measurable assessment of performance and success.

The main outputs for the programme are: a) Jobs created & b) Businesses or holdings benefitting

How much can we apply for? Projects may be eligible for a grant of £2,500 up to a maximum of normally £35,000 to fund specific activities. Higher grants may be awarded to projects demonstrating exceptional output levels.

The Jack Hughes Fund - administered by Herefordshire Community Foundation

The Jack Hughes Fund will fund up to a maximum of 70% pf the cost of training or costs up to a maximum of £150. Funding will be limited to one family member/employee per annum
